- You are required to produce/submit the following certificates at the time of registration for verification purpose:
  - a) Original certificates/ mark sheets of 10<sup>th</sup>, 12<sup>th</sup>, Graduation and post-Graduation (If applicable), work experience and self-attested copies of all.
  - b) Candidates in their final year/term or candidates unable to receive their graduation final year results/certificates are required to produce proof of successful completion of the graduation on or before October 31, 2023.
  - Medical fitness certificate from a qualified (Regd. Medical Practitioner) MBBS/MD from Government/private hospital.
- In case of withdrawal from admission, the withdrawal infimation must be made through email to <u>admissions@mdi.ac.in</u> with details of your Account Holder Name, Account No, Bank name and Branch, RTGS/IFSC Code.
- If you withdraw on or before 11<sup>th</sup> September, 2023 the fee paid by you will be refunded after deducting Rs.1000 (Rupees One Thousand only) as a processing fee.
