


1. INTRODUCTION & BACKGROUND

- Approx. requirement of Reinforcement Steel: 3000 MT (of various diameters 8mm to 32mm)
- Period of Supply: The duration of Construction work is 915 days, however the supply of Steel is required during this period (From the date of issue of LOI)
- Rate to be quoted at their store, godown within 10 km from MDI.
- Contractor appointed and authorized by MDI will be responsible for transportation to the site, handling/storage/waste handling, etc.
- Payment Terms: 75% on finalization of Purchase Order / 25% on deliveryto site with test certificate
- The Manufacturer / Supplier will be empaneled for the complete project duration and quotations to be submitted on monthly and/or quarterly basis to place the order.
- Manufacturer / Supplier to submit Rate only Quote of various diameters 8mm to 32 mm.
- The material will be supplied within 7 days after furnishing intent and payment as per agreed terms along with the manufacturer test certificate and testing to be done at the following interval of supply. Manufacturer test Certificate must be furnished to MDI.
- Test Certificates: Test Certificates as per IS 1786-1985 (or other prevailing and relevant IS Codes) will be submitted by the supplier.
- Weight: Sectional weight of the material shall be strict as per IS 1786-1985
 Specifications and variation will be within permissible limits.
- Length: The Length of the material shall be in standard length of 12m and Above.
- Inspection: MDI will have the right to inspect the material at the site. If so, required joint sampling and testing will be done in the presence of MDI representatives & supplier representatives. Material, if found not as per relevant IS code will be rejected and shall have to be removed by the supplier at his own risk and cost within 7 days of receiving notice from the MDI. The supplier will also immediately refund the entire amount paid against the non-conformity consignment along with an interest of 15% P.A.
