2. Invitation EOI for Empanelment of Manufacturers / Suppliers

Management Development Institute Gurgaon (MDIG) intends to construct approx. 6,50,000 sq. ft. consists of (i) Academic and Administrative Block with Central Dining and kitchen, (2) Student Hostels, (3) Auditorium, (4) Other Allied Buildings of MDI Campus at Mehrauli Road, Sukhrali, Gurugram – 122007. Eligible Manufacturers / Suppliers are invited to submit their respective credentials for supply of CEMENT. MDI will directly procure the CEMENT by making direct payment to the manufacturers/suppliers and an appointed civil contractor will be responsible for transportation to the site, handling/storage/waste handling.
- II. Interested firms must provide the required information strictly in the format provided by this office along with documentary evidence.
- III. The Expression of Interest (EOI) for Empanelment can be downloaded from www.mdi.ac.in from 15 November 2023 Onwards. The last date for submission of the documents is upto 03.00 PM on 22 November 2023. The proposals must be sealed and delivered at the address mentioned in section 3(ii)

4. Brief scope of work

- Applications are invited from reputed, well-established, and financially sound Manufacturers / Supplier for empanelment for the supply of CEMENT as per the requirements below:
- Period of Supply: 915 days during the period (From the date of issue of LOI)
- Cement (PPC/OPC Grade 33/Grade 43)
- Approved makes of Cement: UltraTech, ACC, Ambuja, JK Cement, Shree, PRISM
- Approx. Requirement Cement- 52,000 bags plus the cement for RMC & another miscellaneous requirement for the Construction being undertaken.
- Rate to be quoted at their store, godown within 10 km from MDI.
- Payment Terms: 75% on finalization of Purchase Order / 25% on delivery to site with test certificate.
- Manufacturer / Supplier will be empaneled for the complete project duration and quotations to be submitted on monthly and/or quarterly basis to placing the order.
- Material will be supplied within 7 days' time after furnishing intent and payment as per agreed terms along with manufacturer test certificate and testing to be done at the following interval of supply. Test Certificate must be furnished to MDI.
- Test certificates shall be as per IS 8112 (43 grade), IS 269 (33 grade), or other prevailing relevant IS codes and to be submitted to MDI.
- MDI will have the right to inspect the material at the site. If so, required joint sampling and testing will be done in the presence of MDI representatives & supplier representatives. Material, if found not as per relevant IS code will be rejected and shall have to be removed by the supplier at his own risk and cost within 7 days of receiving notice from the MDI. The supplier will also immediately refund the entire amount paid against the non-conformity consignment along with an interest of 15% P.A.
