- 2. The Institute reserves the right to accept or reject any quotations or to select the item or to reject the bidding process or any quotation wholly or partly without assigning any reason.
- 3. Incomplete bid or receiving the bid after closing date and time are liable to be ignored and rejected.
- 4. Please ensure that Tender document must be signed and stamped on all pages as a token of acceptance of all the terms and conditions.
- 5. No quotations would be accepted by e-mail and only hard copies will be accepted.
- 6. The bid should be submitted on company letter head and should be submitted duly signed by the authorized person.
- 7. The financial bid shall be valid for at least 90 Days. Institute will not entertain any request in respect of escalation of price due to any reason whatsoever.

- 10. Quotation received after the closing date/time will not be considered.

- **12. PAYMENT TERMS:** Payment will be made on yearly basis will be released after successful online delivery of the e-licenses and their activation in the name of MDI Gurgaon and on submission of invoice.

## 13. Termination of contract-

 a. If performance of the vendor is not satisfactory during the period of contract and during the warranty period for the item supplied the standard OEM Warranty, then same will be informed in writing by MDI as warning letter and if inspite of issue of warning letter the performance does not improve to the satisfactorily level as per expectation of MDI within a fortnight then second warning letter will be issued. If after issue of second warning letter also performance doesn't satisfy MDI expectation, then Institute reserves the right to terminate the contract by giving one-month notice in writing without assigning any further reason whatsoever. Decision of competent authority of MDI regarding determining the performance will be final.

## 14. Pre- Qualification Criteria:

- a. The supplier/firm must be either original equipment manufacturer (OEM) or authorized dealer/sole distributor/channel partner. The bidders are essentially required to submit valid authorization certificate from the OEM (Microsoft), failing which the bid shall be rejected.
- b. An undertaking from the OEM is also essentially required stating that they will facilitate the bidder on a regular basis with technology/product updates/hardware support and any kind of support necessary to ensure smooth functioning and security requirements for the entire duration of the contract.

## 15. Bid Rejection Criteria

- a. Bids not sealed would be rejected.
- b. Bids without Profile and declaration on company's letterhead would be rejected.
- c. Certificate on company's letter head that vendor is not blacklisted.
- d. The bidders should have GST & PAN registration and copy of the same to be provided.
- e. Conditional bids would be rejected.
- f. Financial bid not as per the Format-2 (Financial Bid format)
- 16. Any dispute/ difference arising out or relating to this Tender: Matters regarding any dispute shall be referred for arbitration to any officer appointed by the Director of Management Development Institute Gurgaon, whose decision shall be binding and final.
