- All submissions should be uploaded as pdf-files.
- All types of papers, conceptual/theoretical, empirical, review papers and casestudies can be submitted.
- All contributions must adhere to the APA 7th edition referencing style, with a font size of in Times New Roman and 1.5 spacing.
- Papers should provide all author(s) name and affiliation.
- At least one author should register for the conference.
- Extended abstracts should be between 800-1000 words (excluding references).
- Extended abstracts should include keywords, introduction, research methodology, findings, conclusion and contribution.
- Full paper submissions should be between 5000-7000 words (including references).
- Full paper submissions should include keywords, abstract, introduction, literature review, research methodology, findings, conclusion and contribution.
- A maximum of three papers, either as an author or co-author, are permitted.
- Any paper exceeding the word limit will not be included in the review process.
- All papers are to be submitted electronically using the link below and follow this link for regular updates.


