We have audited the data as presented in the placement report of MDI Gurgaon for the Final Placements for the batch of Post Graduate Diploma in Management-Human Resource Management (PGDM- HRM) programme for 2022-24.

Opinion

In our opinion, the Placement report generally complies with the Indian Placement Reporting Standards Revision 2.2. The Placement report contains details for 104 students out of 115 students and the same is duly verified by us.

Basis for Opinion
